D. Education/Outreach Committee

- 1, Dave has been unable to get a response from Dr. Voice on Dinosaur installation. Dave has rocks for Diorama that need to be moved.
- 2. KalamazooRockClub.org domain was transferred from Wrifton to Jerry's name. This is a short term solution and a long term one will involve finding a new administrator for the website. The .com domain will be transferred when a new administrator is found. Jerry sent a list of Administrator duties for the Board to review and use to find a new Website administrator. Jerry mentioned that the KGMS Forum on the website is being plagued by spammers. He is able to delete threads of messages, but not individual ones. He suggests shutting down the forum if a more manageable way to block spammers is not found.
- KGMS Website Domain renewal is due next week and costs \$252 for one year. A 3-year renewal option is available. Jerry suggested KGMS renew for one year and then re-evaluate when new website administrator is onboard.
- 4. Kyle Vicery could be a possible admin for Facebook page. KGMS received a 2-page proposal identifying what functions will be provided, cost and timeline. Initial timeline to be Jan 1 through end of May. Initial cost is \$2500 consulting fee plus additional fees may apply depending on type of work requested. The following considerations were discussed:
 - a. How will work be monitored for accountability?
 - b. Is there a variable option to pay like month to month or hourly rate?

- c. Is a counter proposal option viable?
- d. Can KGMS request a time log for number of hours spent and what specifically was done?
- e. Should a time and activity report be submitted monthly or bimonthly?
- f. Can tailgate, fieldtrips and kids club promotion be included in workload?
- g. Can he work on other social media as well, like Tik Tok?

KGMS to provide a counter proposal that would include \$400 per month and \$200 per month to promote tailgate, fieldtrips and kids club

5. There were 11-12 kids at the September meeting. Kids program was fossils

E. KGMS 2023 Tailgate

- 1. Dave to post information on Facebook
- 2. Date change posted to Facebook, Peachjar, emails, MWF, Area Rock Clubs including KGMS
